## Position Information

This is an opportunity for:

## Who May Apply

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- Current Federal Government employees. (Current GS employees at the same as the advertised positions grade may apply.)
- Candidates outside the Federal Government.
- Current ODNI Staff Reserve Employees. (A staff reserve employee who currently occupies this position may not apply).
- For a detailee assignment:
  - Current Federal Government employees at the same grade as or up to one grade lower than the advertised positions grade may apply.

## Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.
- For a selected non-Federal Government candidate, salary will be established within the salary range listed above, based on education and experience.

## Component Mission

The Office of the Inspector General of the Intelligence Community (IC IG) was established within the Office of the Director of National Intelligence (ODNI) by the Intelligence Authorization Act for Fiscal Year 2010. The IC IG's organizational divisions include Audit, Investigations, Inspections and Evaluations, Mission Support Division, the Center for Protected Disclosures, and Counsel to the Inspector General.

The Mission Support Division provides management and administrative support to the entire IC IG office. The Mission Support Division is composed of multidisciplinary officers who provide expertise in financial management; human capital and talent management; facilities and logistics management; continuity of operations; administration; classification; *Freedom of Information ACT* and *Privacy Act* requests; information technology; communications; and, quality assurance. The Division also provides executive support to the Intelligence Community Inspectors General Forum and its associated committees.

## Major Duties and Responsibilities (MDRs)

Provide leadership and oversight of complex IT projects or programs for the IC IG that may include ill-defined requirements, ambiguity, parallel tasks, multiple dependencies, high risks, and multiple interfaces. Break down high-level strategies into actionable steps.

Coordinate across divisions to ensure project alignment with strategic or corporate objectives; lead the definition and review of customer and stakeholder requirements; ensure plans and schedules are developed and followed throughout the life of the project.



Provide leadership, guidance, and oversight to project implementation and quality assurance by effectively evaluating and monitoring cost, schedule, and performance, assessing variances from the plan, and overseeing the execution of necessary corrective actions.

Lead project performance reviews and processing through control gates, gather important information, and make authoritative decisions about required next steps; oversee the development and maintenance of appropriate project documentation.

Manage IC IG senior leadership expectations and ensure the delivery of quality products and services; lead the examination of project successes and failures and develop solutions to improve products and services.

Analyze, define and document IC IG IT requirements for data, workflows, logical processes, hardware and operating systems environments, network connectivity, systems interfaces, internal and external checks and controls, and outputs.

Manage and maintain the administration of the IC IG SharePoint architecture to include technical requirements and architecture, security, process automation and file management.

Maintain and administer various IC IG web presences; including but not limited to: IC IG Community of Interest; IC IG HCS/ G SharePoint Site; and the IC IG high-side and low-side websites.

Oversee the overall development and administration of the IC IG AWS presence to include cloud migration, security and leading interagency technical exchanges and sharing initiatives.

Develop and communicate project plans and schedules based on a clear understanding of customer requirements and information on project cost, schedule, quality, and performance; provide expert oversight of cost and resource estimates; participate in budget planning activities and develop cost estimating strategies for future projects.

Assist with development of the IC IG IT Strategic Plan, Plan of Action and Milestones, and execution metrics. Serve as the accountable property officer for all IC IG IT-related accountable property and conduct periodic audits and inventories to ensure compliance with policies and regulations.

## **Mandatory and Educational Requirements**

Expert program management, analytic, and critical thinking skills, including the ability to conduct program and management assessments, identify needs and requirements, and develop non-linear process improvement recommendations for implementation across the Intelligence Community.

Expert risk, cost and resource management experience.
