Position Information

This is an opportunity for:

- An internal or external candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade or up to two grades lower than the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
 - Current ODNI Staff Reserve Employees. (A staff reserve employee who currently occupies this position may not apply.)
 - Current Federal Government employees. (Current GS employees at the same grade or one grade lower than the advertised position grade may apply.)



- Candidates outside the Federal Government.
- For a detailee assignment:
 - Current Federal Government employees. (Current GS employees at the same grade or one grade lower than the advertised position grade may apply.)

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- For a selected non-Federal Government candidate, salary will be established within the salary range listed above, based on education and experience.

Component Mission

The Inspector General (IG) conducts, supervises, and coordinates inspections, audits, investigations, and reviews relating to the programs and operations over which the Director of National Intelligence has authority and responsibility.

The Intelligence Authorization Act for Fiscal Year 2010 established the Office of the Inspector General of the Intelligence Community within the Office of the Director of National Intelligence. The ICIG's mission is to provide independent and objective oversight of the programs and activities within the responsibility and authority of the Director of National Intelligence, to initiate and conduct independent audits, inspections, investigations, and reviews, and to lead and coordinate the efforts of the Intelligence Community Inspectors General Forum. The ICIG's goal is to have a positive and enduring impact throughout the Intelligence Community, to lead and coordinate the efforts of an integrated Intelligence Community Inspectors General Forum, and to enhance the ability of the United States Intelligence Community to meet national security needs while respecting our nation's laws and reflecting its values. The Forum consists of the twelve statutory and administrative Inspectors General having oversight responsibility for an element of the Intelligence Community. The Chair of the Forum is the Inspector General of the Intelligence Community.

Major Duties and Responsibilities (MDRs)

- Lead, initiate, cultivate, and maintain productive working relationships with senior Inspector General Officials across the Intelligence Community in order to promote collaboration between and among IC OIG Elements, including activities to foster cooperation with the ICIG Forum and the Forum's committees, and the Council of Inspectors General on Integrity and Efficiency (CIGIE).
- Provide expert, multi-faceted support to the Office of Inspector General of the Intelligence Community (ICIG) to execute annual and long-range planning functions by scheduling, developing, and evaluating related strategic planning documents in support of the ICIG program.
- Oversee, develop, and assist in implementing ICIG managerial framework documents, including the ICIG Strategic Plan, the ICIG Annual Work Plan, and ICIG Implementation Plan.



- Plan and complete assessments of the ICIG's progress towards mission and enterprise strategic objectives and determine how well the ICIG is postured for the future environment through benchmarking, metrics, and trend analysis.
- Assist in preparing and disseminating the ICIG Annual ODNI Top Management and Performance Challenges Report, the IC-Wide Capstone Top Management Challenges Report, and statutorily required Semiannual Reports.
- Serve as the ICIG focal point for monitoring and communicating the status and impact of ICIG recommendations to the ODNI and other IC agencies; take appropriate steps to improve effectiveness of ICIG recommendations.

Mandatory and Educational Requirements

- Superior strategic and tactical planning, critical thinking, and analytical skills in order to propose innovative solutions and implement change with resourcefulness and creativity.
- Superior ability to coordinate, network, and communicate across the ODNI, IC and U.S. Government agencies.
- Superior ability to identify emerging trends and strategic issues and incorporate these into the organization's strategic planning documents.
- Superior communication (written and oral) skills.
- Expert organizational and interpersonal skills to facilitate diverse forums, manage competing priorities, and advocate new ideas/concepts/processes.
- Ability to exercise sound judgment on time-sensitive issues and work collaboratively across the IC and the US Government.
