# **Survey Guidance: Letters, E-Mail Messages, and Introductions for Mail and Electronic Ouestionnaires**

**Note:** This guidance is designed to ensure that GAO policies on evidence and generally accepted government auditing standards are met. The guidance conforms to the generally accepted principles and practices of the appropriate disciplines. Statements that particular actions "should" be taken are practices that are expected to be followed, unless there are good reasons for not doing so. Before deviating from a practice expressed as a "should" statement, staff members must consult with an appropriate staff member in Applied Research and Methods (ARM) or a team specialist and must document the consultation.

### Introduction

This document provides guidance for writing letters and e-mail messages that precede and accompany mail or electronic questionnaires, including guidance on what should be included and why. It also presents a number of examples of introductory sections of mail, Web-based, and MS Word electronic questionnaires (MS WEQs)—that is, questionnaires developed using MS Word that are generally sent as an e-mail attachment. Although you are not required to follow this guidance; it is considered good practice and should help achieve an adequate response rate.

# **General Guidance**

**Be brief:** A major goal of this guidance is to minimize the reading that respondents must do before starting to answer the questions in a questionnaire. To that end, we suggest that only essential information be provided, that information be stated concisely, and that repetition of information in various letters and e-mail messages be kept to a minimum. As to repetition, we realize that some information, such as a phrase or sentence about the purpose of the survey or the names of GAO staff to contact with questions - must appear in more than one communication. However, other information - such as what GAO is, how survey respondents were selected, estimates of the time it will take to complete the questionnaire, and who should complete the questionnaire - generally does not need to be repeated.

We suggest that nonessential information should be avoided. For example:

- Avoid lengthy or detailed descriptions when describing the purpose of the survey. Try to use just one or two sentences.
- Avoid providing the names of congressional committees, subcommittees, or members who requested the study. This information is unnecessary and often confusing; in fact, it may bias answers, affect the types of people who respond, or reduce response rates. In most cases, it is preferable to merely say that the Congress or a congressional committee asked GAO to study the topic.
- Avoid using terms such as "the investigative arm of the Congress" and "an independent audit agency of the Congress" when describing GAO. Use more general terms such as "an agency of the Congress" or "the evaluation arm of the Congress" so as not to imply that we are investigating or auditing the respondents or their program.
- Do not include an outline of questionnaire content. If respondents need an outline, they can easily review the questionnaire.

# Other points to keep in mind

Consistency of terms: Try to use terms consistently. For example, don't use "study" in one place and "evaluation" in another. In particular, do not use "survey" and "questionnaire" interchangeably. Use "survey" when referring to the entire process of collecting data. The term should be used primarily in introductory statements, such as "GAO is conducting a survey of program administrators." Use "questionnaire" when referring to the data collection instrument – the means of collecting the data. For example, avoid saying "Please complete and return this survey by August 1, 2009." Rather say, "Please complete and return this questionnaire by August 1, 2009."

**Third-party endorsements:** A powerful tool to increase response rates for surveys of member organizations is an endorsement statement such as: "The American Association of Airport Executives is notifying its members of the importance of participating in GAO's survey." However, such an endorsement can also introduce bias into the survey results, for example, if the organization is advocating a specific agenda related to the survey topic. Therefore, use caution when enlisting endorsements from such organizations.

Confidentiality: If the engagement team, in conjunction with ARM and OGC, determines that a survey requires a pledge of confidentiality, refer to the guidance in the GAO Policy Manual, section 150, "Portfolio and Risk Management, Part B – Access to Information and Limitations of the Use of Data – Wording of Pledges." If a pledge of confidentiality is offered, it can be included in the survey cover letter or in the activation e-mail message (i.e., the e-mail message that respondents receive when the Web-based survey becomes available for them to complete). If a pledge is offered, it should also be repeated in the introductory paragraphs of the questionnaire. (See Example 5, "Cover Letter for a Mail Survey" (paragraph 2) for an example of a pledge of confidentiality.)

"Return by..." guidance: It is not clear whether requesting due dates in a form like "Please complete and return this questionnaire to GAO by August 1, 2009" improves response rates over more ambiguous forms such as "... within 1 week of receiving the questionnaire." Use your own judgment as to which form you use. However, it is strongly suggested that if actual dates are used, they be confined to the survey letters or e-mail messages and not stated on the questionnaire. These dates are always subject to being extended, depending on the flow of returns. Therefore, it is recommended that they not be included in the questionnaire, which is difficult to change once it has been administered.

**Signatures:** Survey-related letters and e-mail messages, whether printed or electronic, may contain the name and signature of a GAO staff person with authority, such as a managing director, director, or assistant director. For printed correspondence such as notification letters, cover letters, and follow-up letters, a name and a signature should be included. In many cases, the engagement team will have an electronic signature available. If not, contact a Product Assistance Group (PAG) representative to obtain one. For corresponding e-mail messages, a name and a signature are optional. If you wish to include an electronic signature on an e-mail message for a Webbased survey, obtain the electronic signature and ask the QPL contractor to include it in the e-mail message.

# **Letters and E-Mail Messages**

To notify potential respondents that they are to be part of a survey, you should usually send them two communications: (1) a notification letter (for mail surveys) or a notification e-mail message (for Web-based surveys and MS WEQs) explaining the purpose of the survey and that a questionnaire will be following and (2) with the questionnaire, a cover letter or e-mail message explaining the purpose of the survey and the importance of responding. For Web-based surveys, the second e-mail message should also provide instructions about how to access the survey Web site, log in, and complete the Web-based questionnaire. For MS WEQs, this second e-mail message should provide instructions about how to open, save, complete, and return the questionnaire.

After some time following the initial mailing or activation of the Web-based questionnaire, you should send a follow-up letter or e-mail message to nonrespondents. In these communications, you should include a statement pointing out that GAO has not yet received a completed questionnaire. In addition, repeat the survey's purpose and stress the importance of responding. If the questionnaire was mailed, include another copy of it; if e-mailed, attach another copy of the MS WEQ and repeat the instructions about how to access and complete the questionnaire. For Web-based surveys, repeat the instructions about how to access the survey Web site, log in, and complete the Web-based questionnaire.

For letters, as well as envelopes, guidance on address conventions is in the appendix.

# **Notification Letters and E-Mail Messages**

We recommend using notification letters for mail surveys and notification e-mail messages for Web-based and MS WEQs. A notification letter or e-mail message is a brief message that is sent out 2 to 4 business days before the questionnaire is mailed, the Web-based questionnaire is activated, or the e-mail message containing the MS WEQ is sent.

Notification letters and e-mail messages should fulfill these three basic functions:

- 1. <u>Increase the response rate</u>: Response rates have been shown to increase when potential respondents receive notification of the survey before the questionnaire is sent. This notification provides respondents with background about GAO and briefly describes the survey's purpose.
- 2. <u>Test addresses to correct errors</u>: For Web-based questionnaires and MS WEQs, notification allows us to test the respondents' e-mail addresses so that we can correct errors (such as returns from incorrect or outdated e-mail addresses) before the questionnaire is sent or activated.
- 3. <u>Identify inappropriate potential respondents</u>: For Web-based questionnaires and MS WEQs, notification gives inappropriate potential respondents an opportunity to inform GAO that they are inappropriate before the questionnaire is sent or activated.

Note that functions 2 and 3 are most useful for Web-based questionnaires and MS WEQs. For mail questionnaires, it could be a few days between the time the notification letter is mailed and received by the potential respondent. Given this time period, there would probably not be enough time for information to reach GAO so that we could correct the address or identify the appropriate recipient before sending out the questionnaire. Nevertheless, the potential increase in response rate associated with the notification communication outweighs the cost - so we do suggest using them for mail questionnaires as well.

# **Guidelines**

The following guidelines give the basic elements of a (1) well-structured notification letter for a mail survey and (2) an e-mail message for a Web-based or MS WEQ survey. Two examples are provided.

While the results of the survey will generally be provided in summary form in our report, individual answers may be discussed, but they will not include any information that could be used to identify individual respondents.

# **Cover Letters for Mail Surveys**

A cover letter provides information that encourages respondents to participate in a survey and in some cases may help an organizational gatekeeper determine who should complete the questionnaire.

#### Guidelines

Research has shown that following certain guidelines when writing the cover letter will help provide the respondent with a good understanding of what is being asked and why a response is essential. The following guidelines outline the basic elements of a good cover letter, which should be limited to 1 page. Three examples of cover letters for mail surveys are provided.

# Activation E-mail Messages for Web-Based and MS Word Electronic Questionnaire Surveys

When a Web-based survey is activated, an e-mail message is sent to potential respondents, informing them that the questionnaire is now available for them to complete. The activation e-mail message also mentions the earlier notification e-mail message, briefly reminding potential respondents of the purpose and importance of the survey. In addition, the e-mail message tells the respondents how to access the survey's Web site, provides a user name and password for logging on to the site, gives a deadline or time period for completing the questionnaire, and includes the names, phone numbers, and e-mail addresses of GAO contacts if they have questions or problems with the questionnaire.

For MS WEQs, the same information is provided, except that the message includes instructions about opening and completing the questionnaire, which is sent as an attachment to the e-mail message.

### Guidelines

The following guidelines outline the basic elements of a well-structured activation e-mail message to introduce a Web-based questionnaire or MS WEQ. Two examples of activation e-mail messages are provided.

# Follow-Up Letters and E-Mail Messages

Follow-up letters for all types of surveys are sent to those who have not responded at some point after the initial mailing or activation. The timing of the follow-up messages depends on the questionnaire delivery method (that is, mail versus e-mail) and the time period allotted respondents to complete the questionnaire. Depending on the response rate and the time allotted to complete data collection, you may want to send more than one follow-up letter or e-mail message.

In this follow-up communication, note that GAO has not yet received a completed questionnaire, repeat the survey's purpose, and stress the importance of responding. In addition, note that GAO is sending another copy of the paper questionnaire (for mail surveys); the survey URL and the respondent's username and password (for Web-based surveys); or another file containing the MS WEQ (for WEQ surveys).

#### Guidelines

The guidelines described and illustrated here give the basic elements of a well structured follow-up letter or e-mail message. Three examples of follow-up correspondence are provided.

Element	Guidelines	
Date	Spells out rather than abbreviates the month, for example, December 12, 2009	
Salutation	"Dear (Name):" [Optional in e-mail message]

GAO contacts	Provides contacts for respondents' questions, two names, if possible, with telephone numbers, and e-mail addresses	
Instructions [for Web- based surveys only]	<ul> <li>Lists the survey URL and provides the respondents their username and password</li> <li>Provides instructions about how to log in to the Web-based questionnaire</li> </ul>	
Instructions [for MS Word electronic questionnaires only]	<ul> <li>Notes that the questionnaire is an attachment to the e-mail message</li> <li>Explains that the questionnaire can be saved as a Word file on the respondent's computer, completed electronically, and returned to GAO by e-mail</li> </ul>	
Time	Indicates that time is running out to complete the questionnaire and requests that the questionnaire be completed by a specific date or within a specific time period	

<sup>&</sup>lt;sup>a</sup> Web-based questionnaires always contain a final question asking if the questionnaire has been completed and is being officially submitted to GAO. The answer to this question determines whether follow-up e-mails are sent. It is suggested that this question be numbered so that it can be referred to by number in any e-mail. Suggested wording for this question follows:

- 27. Are you ready to submit your final completed questionnaire to GAO at this time? (This is equivalent to mailing a completed paper questionnaire to us. It tells us that your answers are official and final. Follow-up e-mails will not be sent to those who answer "Yes" below.)
- O Yes, the questionnaire is complete and being officially submitted.
- O No, the questionnaire is not yet complete.



#### **Subsequent Follow-Up Letters and E-Mail Messages**

The content of subsequent follow-up letters and e-mail messages is similar to the first follow-up correspondence. Differences are in the first paragraph or two. The following examples 11a, 11b, and 11c show these introductory paragraphs:

#### Example 11a. Subsequent follow-up letter for a mail questionnaire, first three paragraphs

Over the past several weeks, we have sent you two copies of the enclosed questionnaire in order to to collect information on the states' regulation of real estate appraisers. ### **Questionnaire Introductory Section**

The introduction on the first page of a mail - Web-based or MS Word electronic questionnaire - is needed in the event that (1) the respondent has lost the cover letter or e-mail message at the point of starting to answer the questions or (2) one or more of the respondents completing the questionnaire have never seen the cover letter or e-mail message.

This introduction should be as brief as possible so that respondents can begin answering the questions quickly, without being burdened with an overabundance of introductory material. The basic information to include is what the survey is about, instructions for completing and returning the questionnaire, and contact information in the event that respondent requires assistance. It is preferred that most of the information about the survey be included in the letter or e-mail message accompanying the questionnaire.

#### Guidelines

The guidelines described and illustrated here give the basic elements of a well-structured introduction for a mail questionnaire or an electronic questionnaire – Web-based or MS Word.



# Addressing Envelopes and Letters, Including Salutations for Cover Letters

Like you, GAO wants to project the best image possible. Addressing GAO's envelopes and letters in miscellaneous styles does not project as good an image as following specific conventions does. Such conventions help GAO project to the world a uniform, professional look. They also help you, since you do not have to reinvent the wheel each time you address a survey envelope or letter.

The address conventions in this appendix are to be used for surveys and other mass mailings. They include forms for envelope addresses, cover letter addresses, and cover letter salutations. They are based on GAO's preferences as well as the following resources:

In general, the address conventions reflect a formality appropriate to GAO's communications, but they also meet U.S. Postal Service conventions, for example, the capitalized abbreviations for states.

This appendix has three sections: (I) envelope addresses, (II) cover letter addresses, and (III) salutations for cover letters. Section I is divided into six subsections, one for each address line (subsections A–D) and two for foreign addresses (subsections E and F). Examples of almost all the conventions can be found on page 32.

#### I. Envelope Addresses

#### A. First line of address: Courtesy title, name, and professional degree

Put the courtesy title before the full name (*Mr.*, *Mrs.*, *or Ms.*):

#### Salutations are generally based on addresses

Begin with *Dear*. Follow with the courtesy title and last name from the address and a colon:

Dear Dr. Murrell:

Begin with *Dear* and write out the full name with no courtesy title if you do not know whether the addressee is a man or a woman:

**Dear Leslie Wilson:** 

Use appropriate salutations for members of the Congress and the military, Supreme Court Justices, and others:<sup>5</sup>

**Dear Senator Smith:**
