Mr. Johan Bos-Beijer is currently serving on an executive support assignment as Special Assistant to the Naval Inspector General and Senior Advisor to the Naval Seas Systems Command Inspector General. He recently served as Acting Director and Senior Advisor for the DATA Act Program at the Department of the Treasury during a critical transition period for program management which enabled the successful roll out of the program. Prior to that assignment he served as the Director of Analytics & Services, Office of the Technology Transformation Service Commissioner at GSA which he co-conceived and also authored the Analytics as a Service (AaaS) delivery program. His

prior engagements included the conception, design, and implementation of the Consolidated Data Analytics Center (CDAC) for the HHS Inspector General and implementation of the Strategic Solutions and Security Services Division at GSA. Mr. Bos-Beijer joined the federal government in the capacity of Supervisory Auditor at the Department of Education and in subsequent years built the first data warehousing and analytics capability for Federal Student Aid as well as implementation of the National Student Load Data System (NSLDS). He works extensively with members of the Federal and State Inspector General, Law Enforcement, and Program Management communities in program management and oversight, as well as data analytics.

Mr. Bos-Beijer's distinguished senior and executive management career includes positions as Vice President of Operations for a national law practice, Bursar and Director of Finance at institutions of higher education, Chief of Staff and Deputy General Manager for Financial Partners, and the first eCommerce Director in government. He has been principal, or contributing, author of Audit Guides, Identity and Access Management Framework, Managed Security Services, Change Control Management, Debt Management and Collection Systems, and the National Student Loan Data System. He was asked to serve as senior advisor to initiate the Do Not Pay and Improper Payments Recovery Act Analytics program under IPERIA for the US Treasury in 2012 and 2015. As an author the scope of his topics include identity management, auditing, oversight, data analytics, legal management, investigations, and data management.

From 2011 – 2016 he was the government chair of the Emerging Technology Community of Interest and created the first Analytics Big Data Committee. In 2016, he was asked to serve on the White House Office of Science and Technology Data Science Advisory Board. He was a founding member of the Commonwealth of Virginia Data Analytics Alliance. He was a contributor to the U.S. Open Data Center Roundtables for the Open Data Enterprise. His activities also included moderating an agency panel of data standards pioneers for the 2017 Financial Transparency Summit. He has presented as subject matter expert at GAO forums specific to analytics and oversight. Over the past decades he has been the recipient of Government Contributor of the Year, Data Innovation, eCommerce Pioneer, Inspector General Award for Service, and Service to Veterans awards among many others. Mr. Bos-Beijer is serving his second term as Chairman of the Steering Committee for the Interagency Fraud and Risk Data Mining Group.
