- 700+ Comments Received
 - √ 60% comments relate to Section 2 and Appendices A and E
 - ✓ Clarity/Consistency
 - ✓ Combine texts and delete duplicates
 - ✓ Grammatical/Formatting/Minor errors
 - ✓ Shorten Appendix A to cover items in GAS 5.02-5.59
 - ✓ Delete Section 1, repeats GAS 5.02-5.59



Collaboration Tool

- MAX.gov
- Captures draft files and disposition of comments
- Challenges:
 - ✓ User access issues
 - ✓ User inexperience with MAX.gov and other collaboration tools
- Lessons Learned: Being open to and flexible with changes



Section 2 & 3

- Combined External and Modified Peer Reviews
- Challenges:
 - ✓ Deciding how to address comments
 - ✓ Being careful not to impose new requirements
 - ✓ Ensuring consistency throughout the Guide
 - ✓ Emphasizing clarity
- Lessons Learned
 - ✓ Contact agencies for clarity/explanations
